## Booking conditions

Please take the time to read and understand the conditions of booking set out below prior to booking a trip with LebTour. ### 1. Our contract

All bookings are made with LEBTOUR / BEAR ARABIA (us/we). By booking a trip with us you are deemed to have agreed to these Booking Conditions (which constitutes the entire agreement between you and us) and your booking will be accepted by us on this basis. The services to be provided are those referred to in your booking confirmation invoice.

### 2. Deposit requirement

You are required to pay a non-refundable deposit of \$US200 for your booking to be confirmed. If your booking is made within 30 days of the departure date then the full amount is payable at the time of booking.

### 3. Acceptance of booking and final payments

Acceptance of your booking will be confirmed by us in writing. Please refer to your booking confirmation invoice for details regarding final payments. Payment of the balance of the trip price is due 30 days before the departure date. If this balance is not paid on or before the due date we reserve the right to treat your booking as cancelled.

#### **4. Your details**

In order for us to confirm your travel arrangements you must provide all requested details with the balance of the trip price. Necessary details include full name as per passport, date of birth, nationality, passport number, passport issue and expiry date and any pre-existing medical conditions you have which may affect your ability to complete your travel arrangements. If you are 70 years of age or over we also require you to complete and forward a Self-Assessment form. Your booking cannot be confirmed without provision of these details.

#### **5. Late bookings**

For any bookings or additional services accepted within 15 days of departure we reserve the right to charge a CAD \$50 late fee to cover our additional administration costs.

#### **6. Cancellation by the traveler**

If you cancel a trip after making a booking you will lose some or all of the money you have paid for the trip. A cancellation will only be effective when we receive written confirmation of the cancellation. If you cancel a trip:

- 40 days or more prior to departure, we will retain the deposit;
- Less than 30 days prior to departure, we will retain 100% paid by you in connection with the booking.

#### **7. Cancellation by LEBTOUR / BEAR ARABIA**

On very rare occasions, we reserve the right to cancel your holiday due to circumstances beyond our control [War / terrorism / natural disasters, political instability for example]. This may be due to a supplier going into receivership, a series of flights being cancelled, or a hotel closing without notice. In this event, we will offer you another holiday as close as possible to your original reservation. If you decide on a full refund, LEBTOUR / BEAR ARABIA will not be under any further obligation to you.

#### **8. Booking amendments**

LEBTOUR / BEAR ARABIA packages may be transferred in writing to another guest for a 100\$ service fee transfer via Western Union, although no transfers can be accepted within 10 days before arrival.
